2021 Initial Intake Form Mask Wearing Limitations for Manitoba Schools

The purpose of this form is to allow a parent or guardian to indicate that their child falls under the criteria for an exception to the mandatory mask policy for schools. A school or school division that receives this form may request additional information from the parent or guardian.

In keeping with the spirit and intent of the strong recommendations from Public Health, considering the stated preference of the Division's staff (including the Manitoba Teachers' Society), and the feedback from community parents, the Kelsey School Division has made the decision that masks will be mandatory for all staff, students and visitors in our K-12 schools and on school buses for the commencement of the 2021-2022 school year. These requirements are subject to limited exceptions, which are listed below. In addition to practising the public health fundamentals of staying home when you are ill, performing regular hand washing/sanitizing, practicing good cough etiquette, and wearing a non-medical mask may help prevent spreading COVID-19 to others, especially in indoor public spaces when physical distancing of two metres cannot be maintained.

There are very few medical conditions that warrant an exception to the directive mandating non-medical masks be worn on the bus or while at school. If a parent or guardian is concerned about their child's ability to safely wear a mask, they should speak with their child's health care provider.

While a medical note from a health care provider is not required by Public Health or Manitoba Education to accommodate a child's limitations with respect to their child wearing a mask in school or on a school bus, the school division or school may request a note be provided by a parent or guardian from a health care provider to determine whether an exception to the mandatory non-medical mask wearing in schools or on a school bus directive applies to a child.

Inappropriate exceptions to mandated mask wearing have the potential to inadvertently compromise the overall measures related to public health that are implemented in schools to mitigate risk to all and to minimize the spread of COVID-19 in Manitoba schools and communities.

Health care providers have been advised of the following <u>exceptional circumstances</u> which may warrant consideration of an exception to directive mandating mask wearing in schools and on school busses. That is, a child is exempt from being required to wear a mask in school or on a school bus because he or she:

- is under the age of 5 years either chronologically or developmentally and refuses to wear a face covering and cannot be persuaded to do so by their caregiver;
- has severe sensory processing disorders;
- has facial deformities that are incompatible with masking;
- has post-traumatic stress disorder triggered by a face covering;
- has extreme agoraphobia/asphyxia phobia (which is longstanding and pre-dates COVID-19);
- has a medical condition unrelated to COVID-19, including breathing or cognitive difficulties or a disability, which prevent them from safely wearing a mask;
- has a cognitive impairment, intellectual deficiency or autism spectrum disorder for whom wearing a face covering will cause severe distress or disorganization; or
- is unable to apply or remove a covering without help.

PRIVACY NOTICE
